Rules/AVA Membership: All vaulters, coaches, and lungers must be current members of the AVA by March 2018 or complete an AVA non-member form and pay \$25 non-member fee before entering the arena

Releases: All vaulters, loungers, coaches, and grooms must sign both a Los Angeles Vaulting Competition Release and a Paddock Riding Club release form. Parents must sign for minors.

Entries/Deadline: Entries must be completed on line through CompWeb by March 4, 2018, 11:59 PM. Payment and release forms must be postmarked by March 5, 2018. POST ENTRIES ARE NOT ALLOWED PER AVA. Make checks payable to Los Angeles Equestrian Vaulting Club and mail with release forms to Abigail Herrera, 2303 EL Moreno St., La Crescenta, CA, 91214.

Refunds: No refunds will be given after March 4, 2018 without MD/Vet note.

Draw: Draw will be done by computer on March 7, 2018, at 2303 El Moreno St, La Crescenta, CA.

Order of Go: Preliminary OOG will be posted by March 11, 2018 and emailed to participating clubs.

Changes: Changes to the OOG after March 4, 2018 will cost \$10 per change.

Rules: AVA recognized classes follow AVA rules and guidelines. Region I recognized classes follow Region I rules.

Stabling: 12x12 stalls with shavings are available for \$40 per night.

Parking: Free day use and overnight trailer parking are available. Look for signs. Gates locked at 10pm.

Facility: Competition and warm up arenas exceed 75' diameter. Arena is 220x135'. Additional warm up arena is 220x110'. Footing is all weather footing and excellent. Easy ups may be placed by competition arena. Facility opens at 6am. Gate Code is 3919.

Directions from I-210 west: Take I-210 West towards Pasadena. Keep left to continue CA-134 West. Continue 134 west to I-5 south. Take I-5 south to Los Feliz Blvd. east. Exit onto Los Feliz Blvd east. Continue 0.7 miles on Los Feliz to Garden Ave. Left on Garden. Continue to Rigali Ave. Left on Rigali. Entrance is on the right at the end of Rigali.

This document waives important legal rights. Read it carefully before signing.

I acknowledge that competitive and pleasure horse riding and vaulting contains inherent risks of injury and damage to me personally, to my horse, property and to my equipment. Knowing these facts I, nevertheless, in consideration of your acceptance of this form, hereby for myself, my heirs, executors and administrators waive, release, discharge and hold harmless the American Vaulting Association, AVA Region I, Los Angeles Equestrian Vaulting Club, Blake Dahlgren, The Paddock Riding Club and their owners, board of directors, officers and all individual members thereof and all other persons and organizations any way connected with the events, property, boarding, lessons or any other related activities, their representatives, heirs, executors, administrators and assigns from any and all right, claim or liability for damages or for any and all injuries that might be sustained by me including injuries to animals or from any and all claims of any kind or nature that I might have as a result of, or rising out of my participation in any activity. Further, I do hereby acknowledge that this release will extend to any accidents, damages or claims arising out of my participation, caused by my own acts or the acts of anyone or any animal within my control. I further agree that I will defend, indemnify and hold harmless the American Vaulting Association, AVA Region I, Los Angeles Equestrian Vaulting Club, Blake Dahlgren, The Paddock Riding Club and the owners, officers, directors, members and agents or any of them against all claims, demands and causes of action including court costs and attorney's fees, directly or indirectly arising from any action or other proceeding brought by or prosecuted for my benefit contrary to this release extended to all claims of every kind and nature what-so-ever whether known and expressly waive any benefits I may have under Section 1542 of the California Civic Code relating to the release of unknown claims.

RELEASE AND WAIVER OF LIABILITY,
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. YOUR SIGNATURE INDICATES YOUR UNDERSTANDING OF AND AGREEMENT TO ITS TERMS BY SIGNING THIS AGREEMENT, YOU (AND YOUR CHILD) ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH OR PROPERTY DAMAGE FOR ANY REASON INCLUDING, BUT NOT LIMITED TO, THE NEGLIGENCE OF THE PADDOCK, THE TRAINER, ITS OWNERS, EMPLOYEES AND AGENTS ("THE RELEASEES").

I, _____ (and my minor child _____) (hereinafter the "Undersigned") reside at (Street Address) _____, in (City) _____, (State, Zip) _____. (Home Phone) _____ (Email) _____.

In consideration for allowing me (or my minor child) to handle and ride a horse and on behalf of myself, my child or our personal representatives, heirs, next-of-kin, spouses and assigns, THE UNDERSIGNED HEREBY:

1. Acknowledge that a horse or mule may, without warning or any apparent cause, buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person, saddles or bridles may loosen or break - all of which may cause the rider to fall or be jolted resulting in serious injury or death to the Undersigned or any person within close proximity of a horse.
2. **ACKNOWLEDGE THAT HORSEBACK RIDING, THE HANDLING OF A HORSE OR BEING IN CLOSE PROXIMITY TO A HORSE IS AN INHERENTLY DANGEROUS ACTIVITY AND INVOLVES RISKS THAT MAY CAUSE SERIOUS INJURY AND IN SOME CASES DEATH** because of the unpredictable nature and irrational behavior of horses, regardless of their training or past performance.
3. Voluntarily assume the risk and danger of injury or death inherent in the handling or riding of the horse or being in close proximity to the horse or on the premises of the PRC or the failure to wear a protective helmet when riding a horse, and use of saddles, bridles, equipment and gear provided to me by Releases.
4. **RELEASE, DISCHARGE AND PROMISE NOT TO SUE** the Releasees for any loss, damage, injury (including death) or cost to me or my child's arising out of the handling or riding of a horse or being in close proximity to the horse or on the premises of the PRC or the failure to wear a protective helmet when riding a horse, and use of saddles, bridles, equipment and gear provided by Releasees.
5. Release the Releasees from any claim that such Releasees were negligent in connection with my or my child's riding a horse including but not limited to training or selecting horses, maintenance, care, fit or adjustment of saddles or bridles, instruction on riding skills or leading and supervising riders or the use of any equipment provided by the Releasees or being on the premises of the PRC, which resulted in loss, damage, injury or death.
6. **INDEMNIFY, AND SAVE AND HOLD HARMLESS** the Releasees from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with either my or my child's handling or riding the horse or being in close proximity to a horse or on the premises of the PRC or the failure to wear a protective helmet when riding a horse and/or use of saddles, bridles, equipment and gear provided therewith from or contributed to by my or my child's own negligence.
7. Agree to abide by and follow any instructions given or rules established by the Releasees or any of its employees, guides or wranglers with regard to my or my child's riding or handling of the horse or being in close proximity to a horse or on the premises of the PRC or the failure to wear a protective helmet when riding a horse or any saddles, bridles, equipment and gear provided therewith.
8. Agrees that the Undersigned has read and understands the following language of Section 1542 of the California Civil Code which provides "A general release does not extend to claims which the Creditor does not know or suspect to exist in his favor at the time of executing the release which, if known by him, must have materially affected his settlement with the Debtor." Having reviewed this provision, the Undersigned nevertheless voluntarily releases the Releasees from all liability for claims arising out of the matters set forth herein. The Undersigned understands the word "claims" to include all actions, claims and grievances, whether actual or potential, known or unknown and specifically but nonexclusively, all claims arising out of the matters set forth herein. All claims are forever barred by this release without regard to whether those claims are based on the alleged breach of duty arising under contract or in tort or any other claims or cause of action.
9. The Undersigned expressly agrees that the foregoing release and waiver of liability, assumption of risk, and indemnity agreement is governed by laws of the State of California and is intended to be as broad and inclusive as is permitted by California law, and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable for any reason, the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
10. Acknowledge that this document is a contract and agree that if a lawsuit is filed against the PRC or its owners, agents, employees, guides or wranglers for any injury or damage in breach of this contract, the Undersigned will pay all attorney's fees and costs incurred by the PRC in defending such an action.

I have read this document. I understand it is a promise not to sue and to release and indemnify the Paddock, the trainer, its owners, employees and agents for all claims. I have made a free and deliberate choice to sign the Release and Waiver as a condition the Releasees allowing me or my child to ride or handle a horse. I have concluded that the risks involved and the Release and Waiver of Liability is worth the pleasure of horseback riding experience and acknowledges that the same is valuable consideration for this Release and Waiver of Liability.

PADDOCK RIDING CLUB POLICIES AND RULES OF CONDUCT

1. All dogs must be on a leash & under control at all times.
2. No bare feet allowed at any time.
3. Follow rules on written signs.
4. Small children must be under supervision by a parent, guardian, trainer or an instructor at all times.
5. Please, be mindful when parking (think of others).
6. Paddock Riding Club is not responsible for lost or stolen personal articles.
7. By entering the PRC you assumed all risks of being within the proximity of horses.
8. All riders ride at their own risk.
9. Stable hands are directly responsible to the management and anyone wishing to communicate instructions, requests, or complaints are to contact management.
10. No smoking in the barns or elsewhere where "NO SMOKING" signs are posted.
11. Washing of horses is done in the wash rack area only.
12. Please, drive slowly when coming in and out of the PRC.
13. While in the PRC, if you see something that is not yours, DO NOT touch it, take it, or use it. (period)
14. While in the PRC, if you used something, please put it back where it belongs.
15. All riders under the age of 18 must wear a protective helmet (hard hat).
16. Do not touch, pet, feed or go near a horse in a stall.
17. You are in a private property- follow posted rules- Thank you!
18. PRC it is not responsible for anything that might happen to you.
19. Do not gossip about anyone. Leave gossip out of the PRC!
20. PRC reserves the right to refuse service to anyone.
21. If you see something dangerous, please report it to management right away! Thank You!
